
A. Compulsory Requirements:

1. Certificate of incorporation at the corporate Affairs Commission (CAC)
2. Current Tax Clearance Certificate for immediate past three years-2014-2016 with Tax Identification Number (TIN)
3. Current PENCOM Certificate 2016
4. Last three years Audited Accounts of the firm duly stamped by a certified Auditor
5. Current Certificate of Compliance with the provision of the Industrial Training Fund (ITF) Amended 2011, issued by the ITF

B. Other Requirements include:

6. Evidence of financial capability to execute the project, Bank reference and a commitment to provide loan facility for the execution of the contract.
7. Certificate of VAT registration and Remittance
8. Verifiable evidence of similar jobs successfully executed or being executed within the last five (5) years including types, cost location and evidence of award and satisfactory completion.
9. Details of company corporate profile showing experiences, Curriculum Vitae of staff, Contacts, GSM numbers, e-mail address etc
